CHANGES IN THE STRUCTURE AND PROCEDURES OF THE IACS

1. Secretariat

After twenty years of service as Editor-Treasurer of the IACS, Tito Orlandi has stepped down from this position (and during the last Business Meeting he was immediately elected as the next President-Elect). Martin Krause agreed to serve as Editor-Treasurer for the next four years, during which time the Secretariat (including the Treasury and the *Newsletter*) will be moved from Rome to Münster. This change in the structure of the IACS will result in certain changes also in our membership procedures, particularly regarding payment of fees and the dissemination of information. Henceforward, all correspondence regarding the regular activities of the IACS should be sent to:

Regarding payment of fees, we ask our members not to make any payments until they receive a bill soon after the beginning of 1997 (from the new Secretariat in Münster). This bill will provide a statement of how much money you owe through 1997; it will also request that you pay your total fees through the year 2000 in one lump sum. (In the future, we expect to enable members to pay their IACS membership fees at each quadrennial congress, with the request always that payment be made through the next four years, that is, up to the next congress.) The 1997 bill will also include instructions on how to make your payment to the new Secretariat in Münster. All payments will be acknowledged with a printed receipt.

2. Newsletter

Beginning with the next issue, the IACS Newsletter will be printed in and distributed from the new Secretariat in Münster. We expect that henceforth the Newsletter will appear only once each year, its primary purpose being to disseminate information on the following subjects: (a) the quadrennial international congresses of Coptic studies; (b) official activities of the IACS Board and members; (c) names and addresses of IACS members; (d) members' publications forthcoming or in preparation; (e) the IACS World Wide Web Page.

The other types of information that have appeared in the *Newsletter* in the past will be disseminated electronically on a World Wide Web Page and (possibly) through an IACS-sponsored List (or electronic discussion group, or bulletin board). See the next item.

3. The IACS and the Internet

(a) World Wide Web (WWW, «the Web») Pages

The experimental phase of the Web Pages of the IACS will start in November 1996. It will be managed by Tito Orlandi and placed on the server of the CISADU, the electronic centre of the Facoltà di Lettere of the University of Rome «La Sapienza.» It will not have pictures, gadgets, or other paraphernalia, unless strictly pertaining to scholarly information. Initially the main language will be English, as is customary on the Web, and as happened also for the papers of the IACS at the beginning. As soon as possible, the reader will have the choice also of French and German; for this we need colleagues volunteering to make translations.

The main (or first) Web Page will contain the presentation of the IACS (information about IACS history, statutes, membership procedures, fees, privileges, newsletter, and congresses), and links (an index) to the other pages, namely: (1) list of members (with surface and e-mail addresses); (2) latest news (recent information provided by IACS members); (3) Newsletters (the text of the past issues of the IACS Newsletter); (4) publications in preparation (list of works in progress as announced by IACS members); (4) Coptic teaching in the world (list of academic institutions where Coptic language, literature, art, archaeology, or theology, etc., are taught); (5) Coptic centres (list of organizations sponsored by Coptic people for the promotion of Coptic language and culture); (6) links to recommended pages of persons or institutions dealing with Coptic studies (such links may be requested by IACS members, and they will be agreed upon by the IACS Board).

Like the *Newsletter*, the Web Pages will be based on the collaboration of the IACS members, who are requested as of now to send whatever information they deem useful for their colleagues. It should be sent to Tito Orlandi, possibly by e-mail, but also in the traditional way (using the surface and e-mail addresses that appear on the front of this newsletter–for the last time...). (For information that should rather be sent to the new Secretariat in Münster, see above.) Every piece of information sent by the members will find a place in the appropriate Page, and it will remain there until it is no longer relevant. In the future, an archive of such «past news» is also planned.

It is to be expected in the natural course of events that in a few years nearly all IACS members will be equipped to receive the Internet services. For those who are not yet so equipped, it may be useful to know what is needed to begin with: a (personal) computer linked to the Web (e.g. through a university computer centre) and a special software package for accessing the Internet, like «Netscape,» which is freely distributed.

(b) The Listserver

Also in November 1996, an electronic interest group (technically called a «List») for Coptic studies will be activated, centred in the server of the CISADU (see above). An interest group, or List, is a free and rather loose organization whereby interested people may join a listserver, i.e. a program which receives messages from registered correspondents and distributes them to all other registered correspondents, thus making it possible to spread information, and especially to carry on discussions of topics raised by the correspondents.

The List will be called *Coptist* and will start by November. Interested IACS members are invited to register for the Coptist List (Coptic studies interest group) as follows: Send a message to the e-mail address

(e.g.: subscribe coptist emmstel@uni-muenster.de). The List will be a «closed» one, i.e. every new subscriber must be approved by the List owner, in this case Tito Orlandi, acting in the name of the Board of the IACS.

4. Address changes

Please immediately inform the new Secretariat of any change in your address, or of the current address of any members you know who are not receiving mailings from the IACS. Please also keep us informed about your electronic mail address. Information on addresses and all correspondence concerning membership (including notification of changes in membership status and new member applications) should be sent to the Secretariat in Münster (see above for address etc.).

I cannot leave the position of Editor-Treasurer after 20 years without conveying to the IACS members my feelings of how exciting this experience was. It was wonderful to know personally (in most cases) or by correspondence all IACS members, whom I learned to regard as dear friends, taking part in their advancement in scholarship, and sometimes also in their private lives. Thank you all for this. It was equally wonderful to follow the development of the Association, as a promoter not only of Coptic studies, but also of friendship and collaboration.

Now I hope to translate all this into the new electronic media, which will become the necessary environment of our activities, taking care that the coolness of electronics should be warmed by human culture, past and present, which they now help to preserve and spread around. After a period of experiment, some changes will have to be made in the Statutes of the IACS to match the new organization and the different tasks it will require. I trust that the next congress will introduce the IACS into the third Christian millennium well shaped to last and progress.

THE SIXTH INTERNATIONAL CONGRESS OF COPTIC STUDIES

The Sixth International Congress of Coptic Studies was successfully held in Münster, 21-26 July 1996. It was organized by our Association, as one of its statutory tasks, under the able direction of the Congress Secretary, Martin Krause. The Congress was hosted by the Westfälische Wilhelms-Universität Münster and was opened with a speech of welcome by the university Rector.

The congress participants were 234 in number, and 121 papers were read, including a presidential address by Søren Giversen during the opening session, and 13 plenary reports by invited scholars, on recent research in major fields of Coptic studies. Also two workshops were held, on textiles and linguistics, as well as demonstrations of a prototype for the IACS World Wide Web Pages. The *Akten des 6. Internationalen Koptologenkongresses* are being prepared for publication by an editorial committee at the Institut für Ägyptologie und Koptologie, Münster (S. Emmel, M. Krause, S. Richter, S. Schaten).

During the congress, participants were invited to attend a special exhibition of Coptic artifacts at the Gustav-Lübcke-Museum in Hamm, «Ägypten: Schätze aus dem Wüstensand, Kunst und Kultur der Christen am Nil» (16 June to 13 October 1996; 420-page exhibition catalog published by Dr. Ludwig Reichert Verlag, Wiesbaden, 1996), as well as to participate in tours of the Bibelmuseum, the Institut für Ägyptologie und Koptologie, and the Altstadt in Münster.

MINUTES OF THE 15TH MEETING OF THE BOARD OF THE INTERNATIONAL ASSOCIATION FOR COPTIC STUDIES, Münster, 20 July 1996

Present: Søren GIVERSEN (President), Stephen EMMEL, Tito ORLANDI, Martin KRAUSE, Peter GROSSMANN, Anne BOUD'HORS, Gawdat GABRA, Wlodzimierz GODLEWSKI. Excused: Paul-Hubert POIRIER.

The President convened the meeting at 9.00.

- 1. The Congress Secretary reviewed last-minute problems and changes in the program, and the necessary adjustments were determined in detail, including who should be asked to preside over each session. In particular it was decided that every effort should be made to have the papers of Samiha ABD ELSHAHEED and Fatma MAHMOUD read in absentia, as they seem to have been unfairly prevented from attending the congress at the last minute, but sent their papers anyway. The Congress Secretary expressed his particular thanks to Dr. Thomas STERNBERG, Director of the Katholisch-Soziale Akademie, for the accommodations being provided at the Franz-Hitze-Haus. He expressed optimism that the acts of the congress would be published quickly by Dr. Ludwig Reichert Verlag, in a Coptic sub-series of a new series devoted to the Christian Orient.
- 2. The Editor-Treasurer presented the financial report (see below, Business Meeting, point 6), which was approved.
- 3. The list of new members approved by the Board was reviewed, including 36 individuals (Anthony ALCOCK, Elizabeth S. BOLMAN, Nathalie BOSSON, David BRAKKE, Karl-Heinz BRUNE, Allen D. CALLAHAN, Christian CANNUYER, Johannes DEN HEIJER, Tomasz DERDA, Carol DOWNER, Johan FERREIRA, Suzana HODAK, Virpi HUHTALA, Mat IMMERZEEL, Ahmes LABIB PAHOR, Adam LAJTAR, Philippe LUISI-ER, Saphinaz-Amal NAGUIB, Sergio PERNIGOTTI, Bishop SAMUEL, Vera SARTORIUS, Karlheinz SCHÜSSLER, Marianne Aagaard SKOVMAND, Andréas STAUDER, William J. TAIT, Toshimitsu TANA-KA, Jürgen TUBACH, Ernie TUNE, John TURNER, Katarzyna URBANIK-WALCZAK, Risto I. URO, Jos VAN LENT, Gertrud J.M. VAN LOON, Gislaine WIDMER, Penelope WILSON, Nikos ZARKANTZAS), and 2 institutions (Association Francophone de Coptologie, Brooklyn Museum Wilbour Library).

- 4. ORLANDI announced his desire to retire as Editor-Treasurer and described his vision of how the IACS should evolve, particularly through increasing use of electronic communication, such as a World Wide Web Page maintained by the IACS, and decreasing reliance on a printed Newsletter. He volunteered to continue to work on the development of a Web Page even if he were to cease being Editor-Treasurer of the IACS.
- 5. EMMEL expressed his willingness eventually to succeed ORLANDI as Editor-Treasurer (after EMMEL's tenure as President), and hence to see the IACS Secretariat move from Rome to Münster. He proposed that KRAUSE serve as Editor-Treasurer for the next four years while the IACS is in an inevitable period of transition and transformation. KRAUSE agreed, on the condition that he serve only four years and only to help with the transition.
- 6. The Board charged the President-Elect to work with the new Board to carry through necessary or desirable changes regarding the IACS Statutes, the collection of fees, the *Newsletter*, and the *Journal of Coptic Studies*, as they may be affected by the transformation of the IACS Secretariat.
- 7. The Board decided to nominate Hans QUECKE as Honorary President of the IACS at the upcoming Business Meeting.
- 8. The Nominations Committee was established: GIVERSEN (presiding), EMMEL, ORLANDI, KRAUSE, GROSSMANN, BOUD'HORS, GODLEWSKI. GROSSMAN announced his intention to remain in Cairo after his retirement in 1998 and expressed his willingness to continue as Director of the Cairo Center for another term.
- 9.a. The President conveyed an invitation from J.F. BORGHOUTS for the next congress of Coptic studies to take place at Leiden University, and a second invitation from Adel Y. SIDARUS for the next congress to take place at the Universidade de Évora. The Board decided that it would have to interview representatives of both institutions in order to decide how to respond to these two invitations.
- b. The Board met with Paul VAN MOORSEL and Jacques VAN DER VLIET of Leiden from 18.00-19.00 on 22 July.
- c. The Board met with Adel Y. SIDARUS of Évora from 13.00-13.45 on 23 July.

- d. The Board decided to accept the invitation from Leiden, but charged the President-Elect to thank Évora for its generous invitation and to encourage them to explore the possibility of reissuing their invitation in time to be considered carefully for the congress in 2004.
- 10. The agenda for the Business Meeting was set.

The meeting broke for lunch from 13.15 to 15.30.

11. Reconvening in the Arbeitsstelle für Manichäismus at the Institut für Ägyptologie und Koptologie, ORLANDI offered a demonstration of the pilot version of an IACS Web Page that he had set up in Rome.

The President adjourned the meeting at 16.00.

MINUTES OF THE 6TH BUSINESS MEETING OF THE INTERNATIONAL ASSOCIATION FOR COPTIC STUDIES Münster, 25 July 1996 (near the end of the Sixth International Congress of Coptic Studies), Søren GIVERSEN presiding

The President convened the meeting at 16.45.

- 1. The President expressed the thanks of the IACS to the Westfälische Wilhelms-Universität Münster, especially its Rector, Dr. Gustav DIECK-HEUER, for hosting the Sixth International Congress of Coptic Studies; to Dr. Thomas STERNBERG, Director of the Katholisch-Soziale Akademie Franz-Hitze-Haus; to Dr. Ellen SCHWINZER, Director of the Gustav-Lübcke-Museum in Hamm; to the organizing committee of the congress, especially Martin KRAUSE and his competent and energetic assistants (met with acclamation); to the plenary speakers, who also served as presiders over the sections of papers; and to all those who read papers or otherwise actively participated in the congress.
- 2. The members of the IACS deceased after the previous congress were silently commemorated: Alexander BÖHLIG, Pahor LABIB, Jan QUAEGE-BEUR.
- 3. The President welcomed to the congress His Grace Bishop DAMIAN, representing the Coptic church in Germany (met with acclamation).
- 4. The members confirmed all new IACS members elected by the Board (see above, Board Meeting, point 3).
- 5. The President reviewed the IACS's accomplishments since 1992, as follows:
- a. publication in 1992 of the *Journal of Coptic Studies*, vol. 2, edited by G.M. BROWNE and Stephen EMMEL;
- b. publication in 1993 of the acts of the fifth congress (1992), edited by Tito ORLANDI and David W. JOHNSON (with assistance from Stephen EMMEL).
- 6. The Treasurer presented the financial report for the four-year period 1992-1995 (in Italian lire):

The members approved the fi nancial report.

- 7. The President made a plea that all members who have moved or who have not been receiving the *Newsletter* be sure to give their current addresses to ORLANDI.
- 8. The Treasurer made two recommendations regarding the payment of fees:
- a. that members pay for four years at a time, to save the IACS the cost of bank fees;
- b. that for the time being members do nothing except wait for the next issue of the *Newsletter*, which will be printed quickly and which will contain

instructions on how to proceed for the future.

- 9. The Congress Secretary announced the guidelines for the publication of the acts of the sixth congress.
- 10. The President reported that the IACS had this year to choose between two gracious invitations to hold its congress in 2000 either in Leiden or in Évora. He thanked Adel Y. SIDARUS sincerely for the invitation from Portugal, but announced that the Board had decided to accept the invitation from Leiden. Jacques VAN DER VLIET then invited the members to hold their next congress at the University of Leiden in 2000. He described the formation of an organizing committee in Leiden, as well as the facilities that Leiden has to offer. The members greeted this invitation with acclamation.
- 11. The Editor-Treasurer announced his retirement from that position and made suggestions for how the IACS ought to alter its structure and procedures, stressing that the next four years will be a period of transition and transformation, influenced by the use of electronic means of communication. He also announced his willingness to act in an official capacity as the person responsible for experimentation with (a) a World Wide Web Page for the IACS, and (b) a listserver-based electronic List/Discussion Group for the IACS.
- 12. The President announced the nomination of Hans QUECKE as an Honorary President of the IACS. Prof. QUECKE's acceptance was hailed with a standing ovation.
- 13. The members approved the nominations for the new IACS Board (1996-2000), as follows:

President-Elect: Tito ORLANDI
Editor-Treasurer: Martin KRAUSE
Director, Cairo Center: Peter GROSSMANN
Congress Secretary: Jacques VAN DER VLIET

Members at Large: Nathalie BOSSON

Anne BOUD'HORS and Wlodzimierz GODLEWSKI, elected in 1992, continue as Board Members at Large for a second term. The President expressed thanks to retiring board members Gawdat GABRA and Paul-Hubert POIRI-

ER.

- 14.a. On behalf of Lola S. ATIYA, James M. ROBINSON announced the establishment by the Aziz S. Atiya Fund, at the University of Utah, of grants to promote research in all areas of Coptic studies.
- b. The members accepted a proposal by Bentley LAYTON that the new President should write letters to the Presidents of Cairo University and the American University in Cairo, as well as to the President of Egypt, urging that chairs of Coptic studies be established at those two Egyptian universities.
- c. Jan HELDERMAN raised a question about the long-awaited publication by Søren GIVERSEN of a certain Coptic manuscript discovered in the Sudan in the 1960s (known from an Old Nubian version as the «Stauros text»). Gawdat GABRA responded that the publication was well in hand and should appear in September.

The President adjourned the meeting at 17.30.

MINUTES OF THE 16TH BOARD MEETING OF THE INTERNATIONAL ASSOCIATION FOR COPTIC STUDIES Münster, 25 July 1996

Present: Stephen EMMEL (President), Tito ORLANDI, Martin KRAUSE, Jacques VAN DER VLIET, Peter GROSSMANN, Nathalie BOSSON, Anne BOUD'HORS, Wlodzimierz GODLEWSKI, Marie-Hélène RUTSCHOWS-CAYA.

The President convened the meeting at 17.45.

- 1. The Board authorized the former and present Treasurers to transfer the funds of the IACS from Rome to a bank account in Münster, details to be worked out in consultation with the President. Also the official address of the IACS will be changed from Rome to Münster. There was preliminary discussion of other changes in procedures as discussed at the previous Board Meeting and at the Business Meeting, including: consideration of increased use of the ECU («Euro») as a medium of exchange; the desirability of having members pay their fees once every four years (if possible, at each congress, for the upcoming four years); the need to send both a bill for fees due, and a receipt for fees received (thus obviating the use of annual membership stickers as in the past). Discussion will continue as the new executive officers work out the details for the transition.
- 2. The Board authorized ORLANDI to act in an official capacity as the person responsible for experimentation with (a) a World Wide Web Page for the IACS, and (b) a listserver-based electronic List/Discussion Group for the IACS (see Business Meeting, point 11). In this connection, also the less frequent appearance of the IACS *Newsletter* (once per year) was discussed.
- 3. The interim Board Meeting was tentatively set to take place in Leiden, on a Monday in July or August 1998. The President promised to try to give Board members at least six months' advance notice of the time and place of the meeting.
- 4. The Board approved a request from Myriam WISSA for a letter from the IACS in support of an international research project, focused on Ægypte copte et Nubie chrétienne,» being organized by the Groupe de Recherche Archéologique Française sur les Métiers depuis l'Antiquité (Égypte Soudan Libye), under the patronage of the URA 995 of the CNRS-Paris.

- 5. In response to a suggestion from Helmut SATZINGER, the Board reiterated its conviction that the IACS as such should not seek to exercise influence in spheres where it is likely to have little or no useful effect (cf. *Newsletter* 25, pp. 9-10, item 12.c).
- 6. The former Congress Secretary announced that two publishers had expressed interest in publishing the acts of the sixth congress: Reichert and now also Brepols. Negotiations would be pursued. The editorial work will in any case be undertaken by a team at the Institut für Ägyptologie und Koptologie in Münster.
- 7. The status of the *Journal of Coptic Studies* was discussed. The President announced that he had agreed to withdraw his resignation as co-editor (see *Newsletter* 34, pp. 4-5, point 2), and that publication of vol. 3 would proceed with Peeters Press according to the contract currently in force. The Board will begin to explore ways of printing the journal in a less expensive manner in the future.
- 8. In response to a faxed message from Samiha ABD EL-SHAHEED and Fatma MAHMOUD of the Coptic Museum in Cairo, who were prevented at the last minute from attending the congress, the Board sent postcards expressing its regret that they could not attend.
- 9. Some matters concerning the 2000 congress were discussed, particularly the exact scheduling. The Congress Secretary noted that no catering is available at the university between the end of July and the end of August. The President pointed out that scheduling should entail three factors: not to conflict with other congresses of interest to IACS members; convenience of the host institution; convenience of the IACS members (which is a problem mainly because of differing academic calendars). Further discussion will follow.

The President adjourned the meeting at 19.00.

REPORT ON THE TEXTILES WORKSHOP AT THE SIXTH INTERNATIONAL CONGRESS

«Textiles from the Nile Valley: Roman to Early Islamic Period»: Research Group

At the 6th International Congress of Coptic Studies in Münster (July 20-26, 1996) textile specialists and experts in related disciplines held a working session and set up an international research group.

The idea and aim of this group is to facilitate and promote scholarly exchange. It is considered particularly important to increase the exposure of textile research to other special subjects and, at the same time, to establish a forum for those working in related disciplines.

Scope of activity. The region focused on is Egypt and Nubia, as expressed in the title of the research group by the phrase «from the Nile Valley». The chronological framework (with a certain fexibility) agreed upon is meant to encompass post-Pharaonic textiles of the first millennium, i.e. from the Roman to Early Islamic periods.

Tasks. (1) close contact with scholars who deal with other subjects of this region and period (not only archaeology and art history, but also papyrology, epigraphy, theology, literature etc.); the group can be considered a forum within which project groups covering special topics can be set up; (2) closer cooperation with restoration specialists regarding technical aspects of textiles and proper storage, conservation and processing of textiles in excavations and in museums; (3) contacts with archaeologists who expect to find or have found textiles in excavations and referral of specialists for retrieving and processing such material; (4) regular information on current and planned projects, exhibitions, recent literature, announcement of meetings, exchange with other textile organisations etc.

Organisation. In order to ensure a regular exchange of information, meetings are planned to take place at two-year intervals and on particular occasions. A projected date for a future meeting is the International Congress of Papyrology in Florence in 1998, provided our involvement is possible. A meeting in the coming year is also being considered on the occasion of the next «Journée de l'Association Francophone de Coptologie» (May 29-30, 1997) in Colmar. Offers of other places for conferences have been received, for example from the Abegg-Stiftung in Riggisberg.

REPORT ON THE LINGUISTICS WORKSHOP AT THE SIXTH INTERNATIONAL CONGRESS

The Future of Coptic Linguistics

At the VIth International Congress of Coptic Studies in Münster we conducted a workshop titled «Are there cases in Coptic?» Our intention was to analyse a limited set of Coptic language facts (viz. subject marking) within two different grammatical models: functional-typological and formal-generative. What we wanted to show was that these two contemporary linguistic frameworks provide two different analyses of the same set of data. This was meant to encourage discussion of the most adequate interpretation of these data: how the position of the nominal subject can best be described. Contrary to our intentions, the workshop resulted in a highly subjective debate on the merits of particular linguistic theories. In order to improve the quality of further discussion within the field we would like to put forward the following basic assumptions:

- (1) Coptic is one of the world's 5000-6000 languages. Therefore, it deserves to be analysed and described in the same way as any other of these 5000-6000 languages. The fact that Coptic is a dead language requires some adaptation of research methods but no fundamentally different attitude.
- (2) Grammatical models are not religious dogmas but analytic tools. Therefore they should be evaluted, *sine ira et studio*, in terms of their scholarly soundness according to standard scientific criteria.
- (3) Students of Coptic, just like other language students, should become better acquainted with some basic analytic techniques applied in contemporary linguistics. For other subfields of Coptic studies, such as Gnosticism, considerable specialist knowledge, as well as philological competence, is required. Why should Coptic language studies do without?
- (4) It is desirable that the discussion of Coptic language facts should be continued at the next congress. We propose that the organisers of the congress fix a subject beforehand and distribute papers on this subject in advance, as is customary for the Egyptological Crossroads conferences. All methodological approaches should be equally welcome.
- (5) Finally, we would like to emphasize that it is precisely the diversity of competing approaches that makes the scholarly enterprise progress.

GROUPE DE RECHERCHE ARCHÉOLOGIQUE FRANÇAISE SUR LES MÉTIERS DEPUIS L'ANTIQUITÉ (ÉGYPTE - SOUDAN - LIBYE) (GRAFMA): ÉGYPTE COPTE ET NUBIE CHRÉTIENNE

La recherche archéologique et anthropologique sur les métiers dans l'Antiquité chrétienne en Égypte, en Nubie et au Soudan est très peu développée à ce jour. Cette remarque vaut aussi dans une large mesure pour les autres périodes de l'histoire de l'Égypte et de la Nubie. La bibliographie sur la question est fort limitée et les travaux se font en ordre dispersé, faute de contacts réguliers entre chercheurs. De ce fait, il est apparu particulièrement utile de constituer un groupe de recherche qui s'adresse à la fois aux enseignants, aux chercheurs, aux étudiants et aux autres spécialistes.

Les thèmes d'étude seront: (1) les matériaux (exclusivement pierre, brique, bois, os et ivoire, cuir, parchemin, papyrus, papier, sparterie, laine et lin); (2) les techniques de travail; (3) la lexicographie; (4) la prosopographie; (5) les relations d'échange et de diffusion géographique des productions artisanales entre l'Afrique, le Proche-Orient et le Bassin Méditerranéen.

Le groupe se donnera les objectifs suivants: (1) coordonner l'information sur les recherches existantes dans ces domaines; (2) favoriser les échanges et les discussions entre les différentes personnes concernées; (3) proposer des domaines de recherche encore inexplorés; (4) faciliter le travail des chercheurs en leur fournissant toute bibliographie utile; (5) organiser des colloques (nationaux et internationaux) et des tables rondes sur ces thèmes; (6) publier les comptes rendus des réunions et les actes des colloques.

2. Letter from J. den Heijer, Director, Nederlands Instituut voor Arch. en Arabische Studien in Cairo, concerning the teaching programme in Archaeology and Egyptology:

Dear colleagues, With pleasure we announce next year's dates for the teaching programme Archaeology / Egyptology at the Netherlands Institute for Archaeology and Arabic Studies in Cairo (NIAASC). For 1997, the autumn programme of 14 study weeks (560 working hours) has been scheduled from 8 September to 12 December. It consists of a standard course of eight study weeks (ending 31 October) followed by an optional course of six study weeks (ending 12 December). If there is enough interest, the standard course will also be taught in the spring, from 17 March to 18 May.

The teaching programme now forms an integral part of the study programmes in Egyptology and Egyptian archaeology at Leiden University, while it has been accepted as an optional course for advanced undergraduates and PhD students by the other universities in the Netherlands and Flanders partaking in the NIAASC. The programme will be taught in English and students from other universities will be gladly accepted. The NIAASC will provide an assessment of the students at the end of the programme with the individual university's desired format. The maximum number of participants will be sixteen. Therefore, the NIAASC reserves the right to select the students who apply, on the basis of their educational background and experience. Applications should list the study details and the specific interest of the student and should be accompanied by a letter of recommendation from a staff member of the university department involved. Applications for the spring programme of 1997 should reach us by mail or by fax by 1 November 1996. Applications for the autumn programme of 1997 should be submitted by 1 December 1996.
